SERVING OUR COMMUNITY

Serving constituents is at the heart of everything Crow does in Congress. There's no greater example of that than helping to solve their cases and provide support during these challenging times. Beginning in March, Crow recognized the health and economic impact of the COVID-19 on our community and created a COVID-19 guide with hundreds of state, municipal, and federal resources. He has held 31 town halls and "Crow on Your Corner" events to hear concerns throughout the community, produced a COVID-19 safety PSA in 8 languages, and has consistently advocated for federal support for small businesses. Following the realization that the Small Business Association borrower data for Paycheck Protection Program loans was flawed and left CO-6 with less money, Crow led a letter with 28 other members of Congress highlighting the grossly inaccurate data to the SBA.

HELPING SMALL BUSINESSES SURVIVE THE PANDEMIC

A member of the Small Business Committee, Crow fights to get small businesses the help they need during COVID-19.

As the son of a small business owner, Jason understands that aspiring entrepreneurs must have access to resources, a talented workforce, and certainty in order to tackle their unique challenges, create new jobs, and continue to build our economy.

In his first year in office, Jason launched an annual job fair to connect job seekers with jobs, and this year, he brought the effort online with the Workforce Development Series. As Chairman of the Small Business Subcommittee on Workforce and Innovation, he has introduced legislation to protect and grow our small businesses. With COVID-19 hurting small businesses across the district and the country, Jason introduced the Next Generation Entrepreneur Corps Act, a bipartisan bill to spur new business and job creation in underserved communities by starting a competitive fellowship for entrepreneurs.

THINKING BIG TO ADDRESS THE PUBLIC HEALTH CRISIS

Jason advocates for Colorado priorities to help our community band together and overcome this difficult time.

No first-term congressman—let alone any member of Congress—expects to enter their tenure addressing a public health crisis of the magnitude of COVID-19. The impact of this disease has affected nearly every Coloradan in some way, but Jason has set aside partisan differences to help save families and businesses from the worst consequences of this pandemic.

Jason has sponsored and introduced proactive legislation to equip our communities with vital resources, and prepare the next generation of health professionals and frontline workers to address the health care disparities which COVID-19 has made impossible to ignore.

His forward thinking has contributed to the Health Force Resilience Act, a bill which would establish a Health Force to recruit Americans trained in responding to COVID-19 and future pandemics. Inspired by a local doctor in the district, Jason also introduced the Public Health Workforce Loan Repayment Act to design a program that removes financial barriers for students in the health field in order to establish a talent pipeline of future public health workers. Jason also was a leader in finding solutions for health care workers' PPE needs, including introducing a bill that would require President Trump to use the Defense Production Act.

STANDING UP FOR OUR IMMIGRANT AND REFUGEE COMMUNITY

Jason is proud to represent one of the most diverse districts in the country and has worked tirelessly in Congress to advocate for our immigrant and refugee neighbors.

Jason knows our country is stronger and more vibrant because of the contributions of immigrants. As an original co-sponsor of the Dream and Promise Act, Jason has advocated for legislation to modernize our immigration system, keep families together, and provide a pathway to citizenship for our immigrant neighbors.

Since his first days in office, Crow has been a leader in the fight for governmental transparency and accountability. Following a series of disturbing reports at immigration detention centers around the country and refusal by Immigration and Customs Enforcement (ICE) to claim responsibility for the medical conditions at private, for-profit detention centers, Jason stepped in to provide the oversight that ICE has failed to fill with weekly oversight visits to the facility and legislation to increase transparency at detention centers.

PRESERVING OUR COLORADO WAY OF LIFE IN A WARMING WORLD

Jason channeled his military background to push for renewable energy development and ensure our military is prepared for the effects of climate change.

Jason knows that climate change is a national security issue. That's why he made a push for renewable energy development to ensure our military is prepared for the effects of climate change. With the passage of the *Military Installation Resilience Assuredness (MIRA) Act* in his first year in office, Jason established a precedent of recognizing the damaging effects of extreme weather and climate change on the security and resilience of vulnerable military installations.

The *MIRA Act* further solidified the nation's position that climate change is a national security threat affecting military bases close to home like Buckley Air Force Base which is especially prone to wildfires. The 2020 drought and wildfire seasons signaled a desperate need for climate change action now in Colorado. Jason is already making strides to assess water scarcity affecting at-risk military installations, update the Department of Defense's climate change roadmap, and respond to the effects of nature on our military installations' electrical grids.

Colorado Congressman Jason Crow, a Democrat representing Congressional Distict 6, said no one should be in that position. He's taking action with the "Freedom From Price Gouging Act." The bill would cap price increases for Medicare patients to the cost of inflation. If a drug company raises prices beyond that, it has to reimburse customers the profit, and could face a penalty equal to 125% of the increase. Medicaid already does it and Crow said it's working.

ENSURING EVERY AMERICAN HAS ACCESS TO QUALITY. AFFORDABLE HEALTH CARE

Jason believes health care is a right, not a privilege, and that every person in our community should have access to high-quality and affordable health care.

Our current health care system is a patchwork of laws that work for many, but leaves behind others who either are unable to get access to quality services or treatments or are unable to afford them. This means families in Colorado's Sixth District are often left to decide between their health or putting food on the table.

In Congress, Jason is working hard to protect and build on the Affordable Care Act to protect people with pre-existing conditions, prevent any cuts to Medicaid, and ensure that every American can access affordable care. Jason is also building on this work to create a public option and provide reinsurance to drive down health care costs to everyone.

FIGHTING FOR GUN VIOLENCE PREVENTION AND REFORM

As a former Army Ranger, Jason knows how dangerous firearms can be in the wrong hands, which is why he introduced commonsense gun reforms to close gun sale loopholes and put our communities first. In his first term in Congress, Jason served as co-chair of the Gun Violence Prevention Task Force and helped secure over \$30 million dedicated to gun violence research and establishing mental health resources for student survivors of school shootings.
