ICE AURORA CONTRACT DETENTION FACILITY ACCOUNTABILITY REPORT

The Trump Administration informed Congressman Crow's office in February 2025 that it would no longer respond to regular oversight electronic information requests. These requests have been used by Congressman Crow's office under the first Trump Administration and the Biden Administration to complete and corroborate the information provided in these reports, including during the COVID-19 pandemic.

However, as of September 2025, ICE staff will no longer verbally provide information requested by congressional staff during oversight visits for the completion of these regular accountability reports. Congressional staff were instead directed to submit requests for information for the completion of these reports to the ICE Office of Congressional Relations (OCR).

Congressman Crow's staff submitted an electronic information request on January 8, 2026. OCR has not sent over the information requested at this time.

Despite shifting ICE OCR policies, it is a priority for Congressman Crow to provide proper congressional oversight of the Aurora Contract Detention Facility. Congressman Crow and his Congressional office will continue making good-faith efforts to visit the facility and obtain electronic records updates from ICE.

The contents of this report were derived from an in-person Congressional oversight visit by the Congressman's staff at which ICE and GEO staff were unable to provide fulsome answers to the standard questions contained within this report.

Capacity Notes:

- According to ICE staff, the facility's capacity of 1,360 was recently increased to 1,530 detainees.
- Congressman Crow's staff visited each of the housing pods, which were visibly all near capacity.
- Congressman Crow's staff visited the two segregated housing pods. ICE staff said one of the pods is now being used for general population, which had a large number of detainees in the common space (i.e., not in isolation).
- Congressman Crow's staff asked if the facility was at capacity, and ICE staff could not confirm exact number verbally but stated it was slightly below capacity.
- The facility transgender pods were consolidated from multiple pods to one. ICE staff confirmed they moved some transgender detainees to general population or the segregated pod and started using the formerly transgender pods for general population. The last transgender pod had a few transgender detainees. The two formerly transgender housing pods were now visibly filled with general population detainees.

Law Library Notes:

- Law library was in use by three detainees during this visit.
- Based on Congressman Crow's staff visit with Senator Hickenlooper and his staff on 12/20/2025 where there were not Congressional Privacy Release Forms (ICE Form 60-001) available in languages other than English, the law library has since made them available for detainees who access the law library in the following languages: Arabic, English, French, Haitian Creole, Hindi, Portuguese, Punjabi, Russian, Spanish, and Turkish.

Food Notes:

- Food portions were adequate but had limited vegetables, other than beans.



Medical notes:

- GEO Medical staff at the facility confirmed there have not been any issues with staffing and that they are fully staffed in the medical section. Congressman Crow's staff was told they would need to reach out to the ICE Office of Congressional Relations to confirm exact staffing data.
- GEO Medical staff said there are several flu cases being quarantined in the medical unit, but did not confirm precise numbers. Medical staff said there is currently one COVID case, no norovirus cases, and no other outbreaks.
- When asked by Congressman Crow's staff, GEO medical staff said grandfathered transgender detainees are still receiving transgender care.
- COVID-19 data was confirmed by Adams County and Aurora Fire Rescue.

Aurora Fire Rescue confirmed that there were seven calls for service responded to at the Aurora Contract Detention Facility (3130 Oakland Street and 11901 E 30th Ave.) between 1/1/26 and 1/28/26. They were as follows:

- 1/5/26 - Chest pain
- 1/10/26 - Anxiety
- 1/10/26 - Abdominal pain
- 1/16/26 - Chest pain
- 1/23/26 - Lacerations
- 1/25/26 - Fall/head pain
- 1/27/26 - Seizure
