RE: Santa Fe Drive and Mineral Avenue Intersection

Dear Representative Crow,

Arapahoe County supports the proposed improvements at the Santa Fe Drive and Mineral Avenue intersection.

The Mineral/Santa Fe Operational Improvements Project will reduce congestion, reduce crash rates, reduce greenhouse gas emissions, and increase safety and access to transit and multimodal facilities. Approximately 90,000 vehicles per day pass through the Santa Fe Drive and Mineral Avenue intersection. The number of households and jobs within a half mile of the project is set to increase 27 percent and 32 percent, respectively, from 2020 to 2050. Moreover, the density of households and jobs are projected to increase by over 30 percent by 2050. Surrounding developments are expected to add 1,320 dwelling units. The Santa Fe Park development, mixed-use redevelopment of the Equine Medical Center, and mixed-use redevelopment of Aspen Grove will create new residential and employment centers surrounding the Santa Fe Drive and Mineral Avenue intersection. Project improvements will increase access to these employment locations through multimodal options, reduced congestion, and added safety for all users.

The project is adjacent to a Light Rail Station and bus hub, and near one of the most heavily used regional trails in the Denver metro area. The Denver metro area and the City of Littleton are facing a housing shortage, and nearby development that is in the works surrounding the project will bring a wide diversity of new housing stock, plus a variety of new commercial development bringing jobs to the area. With an estimated cost of over \$27M and construction timeline of 18-24 months, the project will provide employment for construction personnel and material suppliers. When completed, the project will reduce traffic crashes, reduce travel delay, increase active transportation and transit usage, and reduce greenhouse gas emissions.

With your support Community Project Funding will lessen the funding gap, effectively leveraging \$12.652 million in regional funding secured for the project. Thank you for your consideration.

Dear Congressman Crow,

I am writing to request your support of a project designed to significantly improve traffic safety, provide multimodal opportunities, and reduce congestion at one of our city's most heavily trafficked intersections (approximately 90,000 vehicles per day). This intersection is also the location of the highest number of traffic incidents within the City of Littleton over the last decade. The project is adjacent to a light rail station and bus hub, and near one of the most heavily used regional trails in the Denver metro area. Nearby development, including high density multi-family housing plus new commercial development is coming to this area adding to the urgency of implementing these community improvements with regional significance and benefits.

The project has already completed design and is shovel ready. The project has multiple partners including private developers, South Suburban Parks and Recreation, Denver Regional Council of Governments, City and County of Denver, Arapahoe County, Douglas County, City of Sheridan, City of Englewood, Regional Transportation District, Colorado Department of Transportation, and the City of Littleton. Funding has been identified and dedicated for more than 80% of the estimated cost of this project. Through design progression and coordination with CDOT, Douglas County, and private developers, the overall design and scale of improvements needed to expand to fit the context of the broader corridor and adjacent land development. The expanded scope will allow the City of Littleton to deliver a comprehensive project that will ensure a long-lasting regional improvement benefitting all users.

In 2024, the City of Littleton was successful in securing \$850,000 through the Congressman's Community Project Funding. However, However, due the exclusion of Community Project Funding within the passed continuing resolution, the City of Littleton is re-applying for FY 2026 funding.
