

ICE AURORA CONTRACT DETENTION FACILITY ACCOUNTABILITY REPORT

Beginning in March 2025, the Trump Administration informed Congressman Jason Crow's office that they will no longer provide electronic files and written updates relevant to the completion of accountability reports detailing conditions at this facility.

Despite this, it is still a priority for Congressman Crow to provide proper congressional oversight of for-profit detention centers, including the Aurora ICE Processing Center. Congressman Crow and his congressional office will continue making good-faith efforts to visit the facility and obtain verbal updates from ICE.

MEDICAL NOTES:

Medical staff confirmed that have been no staffing issues and that they are fully staffed in the medical section.



Medical staff identified that there was one detainee transported that week for specialty care outside of the facility.

Medical staff confirmed hormone therapy is being provided to transgender detainees if they had been receiving it prior to entering the facility.

SUPPLEMENTAL NOTES:

Staff noted during a July 3, 2025 visit that the temperature in one of the male housing pods was 80 degrees.

Following that Congressman Crow's office received further notice that the housing pods were very hot in temperature. During the August 6, 2025 visit, Congressman Crow's staff inquired about the air conditioning and GEO Staff said it was fixed after a freon issue. Congressman Crow's staff spoke with a detainee in the pod who stated that the air conditioning had been out for several weeks and had resumed on August 5, 2025. The detainee stated that temperatures between the July 3, 2025 visit and the August 6, 2025 visit had reached almost 96 degrees. Congressman Crow's staff will continue inquiring with GEO and ICE about adequate air conditioning.

Congressman Crow's staff viewed the general population example meals, and they included an entree with a meat protein and sides for each meal. Staff were also shown sample meals for detainees with a vegetarian restriction, and it included eggs as a protein.

According to GEO staff, outside activity on the field has been halted due to an ongoing investigation into the two detainees who escaped on March 18, 2025. When we asked GEO staff when detainees would be permitted to start using the field again, they did not give an exact timeline for the outdoor field but confirmed that the outside basketball court was now open for use, and it was in use during the visit by detainees.

On Thursday, July 31, 2025, detainees notified advocacy groups that the water was not functioning properly beginning at 6:15 am. The advocacy group notified Congressman Crow's office. Congressman Crow's staff went to the detention center at 1:30 pm to ask GEO staff about the water issues and were told by Warden Baltazar the water was back on and that the facility had been doing required testing per the city that took longer than expected. At the visit on August 6, 2025, GEO staff said drinking water was available during the outage.
