A BILL

To sunset the Office of the Special Inspector General for Afghanistan Reconstruction, to provide that employees of the Office are eligible for the Interagency Career Transition Assistance Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Sunsetting the Inspec-
5 tor General for Afghanistan Reconstruction Act” or the
6 “SIGAR Act”.

1 **SEC. 2. SUNSET AND TRANSITION ASSISTANCE FOR OFFICE**
2 **OF THE SPECIAL INSPECTOR GENERAL FOR**
3 **AFGHANISTAN RECONSTRUCTION.**

4 (a) **SUNSET.**—Section 1229(o)(1) of the National
5 Defense Authorization Act for Fiscal Year 2008 (5 U.S.C.
6 415 note) is amended by striking “terminate 180 days”
7 and all that follows through the period at the end and
8 inserting “terminate on January 31, 2026.”.

9 (b) **ELIGIBILITY FOR ICTAP.**—Any individual who is
10 an employee of the Office of the Special Inspector General
11 for Afghanistan Reconstruction on the date of the enact-
12 ment of this section shall be—

13 (1) eligible for appointment under the Inter-
14 agency Career Transition Assistance Program under
15 subpart G of part 330 of title 5, Code of Federal
16 Regulations (or any successor regulation), subject to
17 the terms and conditions of such Program;

18 (2) considered to be displaced and ICTAP eligi-
19 ble as those terms are defined in section 330.702 of
20 such subpart (or any successor regulation) for pur-
21 poses of the Program; and

22 (3) considered to have established proof of eligi-
23 bility under section 330.710 of such subpart (or any
24 successor regulation) for the purposes of the Pro-
25 gram.

1 (c) TRANSFER OF FUNDS.—Any unobligated funds
2 available for such Office on February 1, 2026, may be
3 transferred to and merged with any available account
4 under any Act making appropriations for the Department
5 of State, foreign operations, and related programs. In car-
6 rying out any such transfer, the Secretary of State shall
7 consult with the Committees on Appropriations and For-
8 eign Relations of the Senate and the Committees on Ap-
9 propriations and Foreign Affairs of the House of Rep-
10 resentatives.
