Bridge House fully supports the City of Englewood in their efforts to bring our Ready to Work Program to their city.

Our Ready to Work program combines paid employment in one of our two social enterprises (landscaping and commercial catering) with housing and support services for one year, as means to independence for adults experiencing homelessness. Ready to Work currently operates in Boulder and Aurora, and has capacity for 94 "trainees" at one time. Expansion into Englewood will increase our capacity to approximately 144.

Bridge House believes that our work-first model is a key component of ending homelessness. Work. Our solution breaks the cycle of homelessness for a segment of the homeless population that has been largely ignored to the detriment of the individual and community. ## Member-Sponsored Project Support Letter – Bridge House

To Whom it may Concern,

As a community leader and pastor, I could not be prouder of the work our region has done to foster a community characterized by care and support for our vulnerable citizens. The cities of Englewood, Littleton, and Sheridan (the Tri-Cities), in partnership with Arapahoe County, have made great strides to support constituents working to provide for the needs of those experiencing poverty and homelessness. These efforts have resulted in not just a vibrant service provider community, but a culture that has begun to attract new organizations to the area. The initiative to establish the Bridge House/Ready to Work program in Englewood exemplifies this encouraging trend.

The Tri-Cities has seen success in building collaboration around addressing homelessness at both the grassroots and governance levels. In 2017, community leaders from the faith, nonprofit, city government, and police sectors joined together to establish the Change the Trend Network, an independent nonprofit organization focused on building social capital around addressing homelessness at the grassroots level. Today, Change the Trend hosts over thirty network agencies from across the region and meets weekly to engage collaborative work.

Concurrently, the mayors, city managers, and chiefs of police within the Tri-Cities banded together to form the Tri-Cities Homelessness Policy Group (TCHPG) in order to build greater regional cohesion in our approach to addressing homelessness. Since the inception of Change the Trend and TCHPG, these efforts have enjoyed a strong working relationship, with Change the Trend leadership sitting on TCHPG and regional leaders regularly contributing to Change the Trend.

These dual efforts have resulted in a stakeholder community characterized by trust, collaboration, and collective action. The Tri-Cities region is truly a place where service providers thrive, shared projects are undertaken with a spirit of partnership and enthusiasm, and our vulnerable neighbors are cared for. The next steps in our journey to address homelessness are to formalize the coordination of services through resource navigation and build pathways out of homelessness through housing services and a robust array of wrap-around support.

When the Bridge House/Ready to Work program was awarded a grant to conduct a study of possible areas to replicate their program, they chose the Tri-Cities in large part because of the vibrant service provider culture present in the area. Bridge House's program is proven to be a successful service to individuals seeking to move beyond homelessness through vocational empowerment. Their current locations in Boulder and Aurora boast a 73% success rate, measured by job and housing retention amongst their graduates.

From my vantage point, I am deeply impressed with the support Bridge House leadership has received from the Tri-Cities leadership as they enter the process of launching this new location. Bridge House leadership have been given access to senior level city staff, who have made themselves available to help identify possible locations for their program. Additionally, the broader stakeholder community has already begun building partnerships of support to help the program launch successfully. This process constitutes yet another example of health and vitality amongst the Tri-Cities region, and renders this project deeply worthy of continued support.
